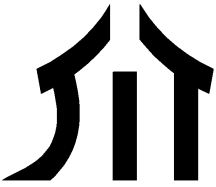

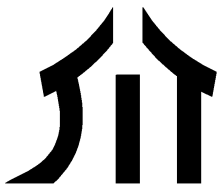

This warranty does not include:

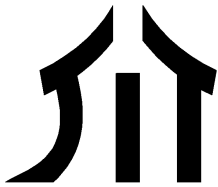
- Any condition resulting from other than ordinary residential wear or any use for which the product was not intended
